- 1) Motion to approve Minutes March 23, 2017 (Approved - J.White/B.Conlon)
- 2) Trustee Report – Stan
 - PJCC cash account estimated @ \$ 400,496
 - Capital fund @ \$ 52,637
 - CC budget approved by trustees as presented \$ 1.78 million
 - Locker room complete/ renovating sauna
 - Open 6 AM to 9 PM
 - RFQ out for fitness center/ personal trainer 12 months
- 3) Membership report
 - Golf membership \$ 909K (+ 14k from 2016 same time)
 - Tennis membership \$ 117K (- 13K from 2016)
 - Residents Passes \$ 4k
 - Range membership est. \$ 750
 - Forecast excellent to meet membership goals golf (budget \$ 915k)

 - Aeration holes 90% filled in/ greens & fairways are being fresh mown

 - Worm spray program worked well worth investment
 - Seed is germinating on # 3 hill
 - # 12 completion/seeding is a future project dependent on budget
 - Split rail Fences installed on par 3's
 - Resolution of SCWA bill issue requires capital to fix well which may exceed budget/ brian requested a motion to have trustees authorize up to \$ 3,000 additional funds for him to fix problem with due diligence – Motion Approved unanimously
 - Fall aeration 4-5 days split between early weeks of September
